

Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Salaiya-Paharhai Limestone Mine over an extent of 9.84 hectares in Vijayraghavgarh Tehsil, in Katn District of Madhya Pradesh State

Sir,

Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 30/05/2024 in the presence of your representative Shri Manoj Kumar Roy, Shri Arvind Tamrakar (Geologist) and other mines officials. The document of above mentioned mine was approved vide letter No. MP/Katni/Limestone/MPLN/MOD-45/2018-19 dated 17.06.2019 incorporating proposal of working from 2019-20 to 2023-24. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

11(1)	As per CCOM guideline all boundary pillars are need to be fixed in appropriate location.	Physical appearance of most of the boundary pillar were not observed in appropriate location as per their coordinates marked on them in the lease area. Boundary Pillars need be fixed based on DGPS Report.
	As per statutory provisions, 7.5 meter barrier zone of lease boundary must be kept in original position. However lessee has taken permission of common lease boundary from Director, Directorate of Mine Safety, Jabalpur vide their letter dated. 27/07/2019.The validity of said permission already expired one year back i.e on 03/05/2022.	During the inspection it wa observed that permission of competent authority related with common boundary had not acquired and submitted to this office so far.

- 04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
