Following provisions of MCDR, 2017 were found violated in your above mine during the inspection by Shri Akash Arun Mittarwar, Assistant Mining Engineer on 25/05/2024 in the presence Shri Ram Bihari Bagri (Mining Engineer) & Shri Arvind Tamrakar (Geologist) as follows:-

No 11(1)	No holder of a mining loose shall commence on community interviews in any area execution
11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016, read with MCR(Amendment),2021 notified in Gazette of India vide dated 02/11/2021.
	MP/Katni/Limestone/MPLN/MOD-07/2019-20 dated 25/06/2019 incorporating proposal of working from 2019-20 to 2023-24. During the inspection following violations were observed:-
	<ol> <li>A permission of common lease boundary under Regulation 111(1) of the MMR,1961 has been taken from Director, Directorate - General of Mines Safety, Jabalpur vide their letter dated 27/07/2015; the validity of said permission expired on 03/05/2022 and renewed/ extended permission for common lease boundary has not acquired and submitted to this office so far.</li> <li>The recovery study report is not submitted in this office till date as per undertaking given by lessee on 01/01/2024.</li> </ol>
31(4)	The plans and sections required under these rules shall be maintained up to date 1[showing also the respective proposal of approved mining plan for various activities pertaining to that year, within three months] in case of category 'A' mines as referred to in clause (a) of sub-rule (2) of rule 55, and within twelve months in the case of any other mine.
	• The updated plans and sections are not submitted.

33 The holder of a mining lease shall, on or before the 30th day of June every year submit to the authorized Officer, as the case may be, and the State Government, a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32.

Copies of plans and sections under rule 32 of MCDR-2017 have not been submitted.

- 1. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 2. The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 read with MCDR-2021 (Amendment) are not found satisfactory.
- 3. You are advised to rectify the violations of abovementioned rules immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
