Sub. : Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect to Jamuwanikhurd Limestone and Dolomite **Mine** over an extent of **7.89 hect.** in **Katni** District (M.P.)

Sir,

The following provisions of the Mineral Conservation and Development Rules 2017 were found violated in your above mine during the inspection on 26/06/2024 by the undersigned, accompanied by Shri Ramashish Kumar, Mining Engineer of the mine and Shri Arvind Kumar Tamrakar, Part time Geologist of the mine.

11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016. Read with MCR (Amendment),2021 notified in Gazette of India vide dated 02/11/2021 The Review of Mining Plan of above mentioned mine was approved vide letter No.- MP/Katni/limestone/RMP-40/2022-23 dated 26/08/2022 incorporating proposal of working from 2022-23 to 2026-27. During the inspection it was found that following activities have been carried out with violating the approved proposals: - Benches in mineral have not been kept sufficiently advanced resulting upper bench is close to merger with subsequent lower bench. (Third and fourth bench of Southern face in the Quarry)
12(4B)	For the exploration done under sub-rule (3) and (4), the holder of mining lease shall submit to the State Government and the Indian Bureau of Mines, a Geological Study Report prepared in the manner specified in the Minerals (Evidence of Mineral Contents) Rules, 2015, within three months after the completion of the exploration work. As per approved Review of Mining Plan 5 no. of boreholes have been carried out for the purpose (Please refer Form I submitted through letter dated 25/03/2023) but copy of the Geological Study Report(GSR) has not been submitted to this office even lapsing of twenty months after completion of boreholes
31(4)	The plans and sections required under these rules shall be maintained up to date within three months in case of category 'A' mines as referred to in clause (a) of sub-rule (2) of rule 55, and within twelve months in case of any other mine The plans & sections were not found updated on quarterly basis as required under this rule and not maintained at mines site office.

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 are not found satisfactory.

4. You are advised to rectify the above violations immediately and intimate the position to this office
