The following provisions of MCDR 2017 were found violated in your above mine during inspection carried out on 13^{th} June 2024 by the undersigned in presence of the mine officials S/Sri Satyabadi Sahoo, Mines Manager, and other Officials..

During year FY 2023-24 it was proposed to drill 17 nos. of exploratory bore holes against which only 3 boreholes have been drilled. |
| | 2. During year FY 2023-24 it was proposed to carryout mining operations with 6m high benches in Top A Quarry of the mine. However, during inspection it was observed that all along the Top A Quarry the benches are not maintained as per proposed height and in most of the places benches have merged thereby increasing the height of the benches thus making it unsafe for mining. |
| | 3. During FY 2023-24 it was proposed to produce ROM to a tune of 999905 tonnes against which only 245400 tonnes of ROM has been produced thereby causing deviation in land use pattern and (-75.45%) of deviation from the proposal. |

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.
