The following provisions of Mineral Conservation and Development Rule, 2017 (MCDR, 2017) were found violated in respect of the above said mine during inspection on 12.07.2024 by undersigned along with Shri A K Pany, AME of this office, in presence of Shri Syed Farooq, CEO, Shri A. Gururaj, Mines Manager and other Mine officials

	(ii)	As per the approved mining plan, +35% Fe is considered as Cut off and	
		100% of ROM proposed as salable. However, in Sl. No. 3 of PART-V	
		generation of 85910 tonne of mineral reject with grade 44% Fe is reported.	
		Further, the closing stock of unprocessed mineral reject stock is not	
		matching after depleting the processed mineral reject quantity.	
	(iii)	In Sl. No. 3(ii) of PART-VI the opening stock of "45% to below 51% Fe"	
		lumps is not matching with the closing stock of same grade for the year	
		2022-23.	
	(iv)	Details of Royalty, DMF & NMET reported in PART-VII do not match	
		with the information furnished in Sl. No. 2 of PART-III.	

- 02. The mining operations and dispatches may be suspended and any action under sub-rule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
- 03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 04. You are therefore directed to show cause within a period of **thirty (30) days** from the date of issue of this notice, as to why action under sub-rule (7) of Rule 45 of and Rule 62 of MCDR (Amendment), 2021 shall not be taken against you.
- 05. You are advised to rectify the above violations immediately and intimate the position to this office **within 30 (thirty) days** from the date of issue of this notice.
