# CIRCULAR

Three (03) posts of Superintending Officer (Ore Dressing) in the Pay Level-13 (Rs. 123100-215900/-) are vacant in Indian Bureau of Mines under the Ministry of Mines and is to be filled up by deputation including short term contract basis.

02. The Superintending Officer (Ore Dressing) is responsible to Supervising and coordinating and conducting experiment on mineral beneficiation. Experimentation on pilot plant scale raising the grade of ores and minerals. Preparation of project reports on milling and recovery of ores, minerals and production of concentrate.

03. As per the Recruitment Rules for the post of Superintending Officer (Ore Dressing), the candidate to be considered for appointment by deputation including short term contract from the Officers under the Central Government or State Government or Union Territories or Public Sector Undertakings or recognised research Institutions or Autonomous bodies or statutory organizations;

(A)(i) holding analogous posts on regular basis in the parent cadre or Department; or

(ii) with five years' service in the grade rendered after appointment thereto on a regular basis in Level 12 (Rs. 78800-209200) in pay matrix or equivalent in the parent cadre or department; and

(B) Possessing the educational qualification and experience as below :-

(i) Masters' Degree in Ore Dressing or Mineral Processing or Geology or Chemistry or Physics from recognized University or Institution, or Bachelor of Engineering or Bachelor of Technology degree in Mineral Engineering or Chemical Engineering or Metallurgy from a recognised University or Institution, and

(ii) Twelve (12) years' experience in a recognised laboratory or plant of Central Government or State Government or Public Sector Undertakings or recognized research Institutions or Autonomous bodies or Semi-Government or statutory organizations conducting Mineral Beneficiation and/or Mineral Characterisation for beneficiation of various ores and minerals.

**Note-1:** The departmental Officers in the feeder grade who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

**Note-2:** The period of deputation including the period of deputation in another excadre post held immediately preceding this appointment in the same or some other organisation or department of Central Government shall ordinarily not exceed five years.

**Note-3:** The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

04. The deputation period will be initially for 03 years and will be considered for further extension on the basis of requirement of this department and NOC from the parent department. However, the officer may also consider for pre-mature reversion to the parent cadre by serving 03 months advance notice to the parent department as well as to the officer in terms of provisions contained under DOPT OM No.6/8/2009-Estt. (Pay II) dated 17.06.2010.

05. Applications received after the closing date will not be entertained. Also, advance copies of applications or not accompanied with all the above certificates/enclosures are liable to be rejected.

06. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
