Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Badagaon Limestone Mine over an extent of 5.97 hectares in Badwara Tehsil, in Katni District of Madhya Pradesh State

Sir,

Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 28/06/2024 in the presence of your representative Shri Ankit Goenka, Shri Subham Sahu and other mines officials. The document of above mentioned mine was approved vide letter No. MP/Katni/Limestone/RMP-01/2019-20 dated 28.06.2019 incorporating proposal of working from 2019-20 to 2023-24. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

33	Copies of plans and sections to be submitted – The holder of mining lease shall on or before the 30th day of the June every year submit to the authorized officer, as the case may be, and the State Govt., a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32.	Copies of plans and sections under rule 32 of MCDR-2017 have not been submitted.

02. Further, it is brought to your notice that the above violations constitute an offense punishable under rule 62 of Mineral Conservation and Development Rules, 2017.
03. Further, non-compliance of the rule 11(1) of MCDR, 2017 may lead to the suspension of mining operations under the provisions of rules 11(2) of Mineral Conservation and Development Rules, 2017.
04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
