Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 28/06/2024 in the presence of your representative Shri Ankit Goenka, Shri Subham Sahu and other mines officials. The document of above mentioned mine was approved vide letter No. MP/Katni/Limestone/RMP-01/2019-20 dated 28.06.2019 incorporating proposal of working from 2019-20 to 2023-24. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.
