Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Harraiya Limestone Mine over an extent of 7.605 hectares in Vijayraghavgarh Tehsil, in Katn District of Madhya Pradesh State

Sir,

Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 30/05/2024 in the presence of your representative Smt Gunjan Goenka, Shri Krishna Gautam, (Mining Engineer) and other mines officials. The document of above mentioned mine was approved vide letter No. E 8085 MCDR-MPC0LST/26/2023-JBP-IBM\_RO\_JBP dated 31.10.2023 incorporating proposal of working from 2023-24 to 2027-28. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

In 2023-24, 06 numbers of boreholes were drilled but these boreholes were not drilled as per their proposed location shown in the approved Surface Geological plan.
	Backfilling was proposed near pit 1 towards NE part of Barrier zone of the lease.	As per proposal, Backfilling was not done near pit 1 towards NE part of Barrier zone.
	It was proposed to produce 381839 metric tons of Limestone in the year 2023-24.	Actual Limestone production during the year was less i.e., 247225 tons. The limestone production was lagging from the approved proposal.
	400 numbers of sapling was proposed during the year 2023-24	Plantation on proposed site found not carried out.
19	The log books may be maintained in electronic form or in hard copy and shall be made available to the authorised officer on demand.	Log book of Machinery deployed in mines was not maintained properly.

02. Further, it is brought to your notice that the above violations constitute an offense punishable under rule 62 of Mineral Conservation and Development Rules, 2017.

03. Further, non-compliance of the rule 11(1) and 19 of MCDR, 2017 may lead to the suspension of mining operations under the provisions of rules 11(2) of Mineral Conservation and Development Rules, 2017.

04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
