Following provisions of MCDR, 2017 were found violated in your above mine during the inspection by Shri Akash Arun Mittarwar, Assistant Mining Engineer on 24/05/2024 in the presence Shri Manoj Kumar Roy (Mining Engineer) & Shri Arvind Tamrakar (Geologist) as follows:-

	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic Minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016, read with MCR( Amendment),2021 notified in Gazette of India vide dated 02/11/2021. The Modification of Mining Plan of above mentioned mine was approved vide letter NoMP/Katni/Limestone/MPLN/MOD-16/2019-20 dated 24/10/2019 incorporating proposal of working from 2019-20 to 2023-24. During the inspection following violations were observed:-
