Rule 11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of subsection (2) of section 5.
	 i. Against the proposed 139195 T only 4785 T are reportedly produced and only 1015 Cu.m waste generated against the proposed 29,557 Cu.m which distorting the proposal by 96%
	ii. The benches of the pit has not been systematically developed which resulting the creation of high wall in the northern direction of the lease.
	iii. The backfilling of the 7.5 m barrier zone in the northern side of the lease has not been carried out as proposed in the approved Review of Mining Plan for the Reporting Year 2022-23.
