The following provisions of Mineral Conservation and Development Rule, 2017 (MCDR, 2017) were found violated in respect of the above said mine during inspection on 01.10.2024 by the undersigned along with Shri A K Pany, AME of this office, in presence of Shri Amartaluri V. Rao, Mines Manager and other Mine officials.

Rule s	Nature of Violations Observed
11(1)	As per Review of Mining Plan approved on 23.11.2021, there is proposal of
	construction of 25m garland drain during the year 2023-24. During
	inspection, it is observed that the same has not been constructed.
12(1)	During the inspection, it is observed that around 1.5 lakh tonnes of Iron ore
	fines stacked in the mine. Stacking of such a large quantity of fines in the
	mine during rainy season is not appropriate in the view of conservation of
	mineral as there is chance of flow of mineral by rain water.

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.



04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
