The following provisions of Mineral Conservation and Development Rules, 2017 were found violated during inspection of the above mine on 02.07.2024 by undersigned accompanied by Sri A. S. Mahapatra, Agent cum Sr.V.P (Mining), Shri S.C. Pradhan, Mines Manager & Shri Abhijit Sen, Sr. V.P (Geology).

	Mining operations should have been undertaken in accordance with the Mining Plan/Review of Mining Plan.		
11(1)	The Review of Mining Plan was approved vide letter no. BBS/SNG/IRON/2187/RMP/2022-23 dated 10.01.2023		
	and following deviation was observed during inspection		
	1. The proposed mineral production of ROM 7350000 MT in 2023-24 but production of ROM reported		
	5449579.070 MT which is approximately 74% of proposal.		
	2. During mine visit it was observed that that bench parameters are not as per proposal. The benches not		
	developed as per proposal. The maximum height of bench was proposed 9 meter and minimum width 9-		
	12 meter but bench height in Kusum pit in many places 12-14 meter and width also less than proposal.		
	The bench height between BP13-BP14 is 15 meter.		
	3. The proposal for garland drain was given in 2023-24 for 230 m but it was observed garland drain not done		
	and existing drain is filled with silt and boulder.		
33	The holder of a mining lease shall, on or before the 30th day of June every year submit plan and section as per		
	Rule to the authorised officer but it was observed that the surface plan & surface geological plan submitted are		
	not submitted as per actual field position and the bench parameters shown in plan is not surveyed properly. The		
	plan is also not matching with the drone data submitted.

	1. It was observed that the ex-mine price for the CLO below 62%Fe is less than the Ex-mine price of fines 60-62%fe in the month of April'24.

	60-62% Fe Rs 3912/- in the month of May'24. This shows low grade ore Ex-mine price is more of
