The following provisions of the Mineral Conservation and Development Rules, 2017 read with Mineral Conservation and Development (Amendment) Rules, 2021 were found violated during the mining operation for the year 2023-24 in your above said mine during inspection on 24.10.2024 for examination of Review Of Mining Plan submitted Under Rule 17(2) Of MCR, 2016 and also for MCDR and SDF validation by Dr. Omksha Murthy, Regional Mining Geologist along with Shri Ashish Kumar Behra, AMG of this office.

11(1)	<p>The Mining operations required to be carried out in accordance with the approved Modified to the approved Mining Plan document vide letter no. 279/68/89/BNG dated 29/11/2022, However, during the inspection deviations were observed in mining operation vis-à-vis approved document and are as follows:</p> <ol style="list-style-type: none"> For the year 2023-24, it was proposed to mine the reef ore between section line BB' and DD', however, during the inspection it is observed that there is no Production & Development carried out at the proposed location and the same was verified by Updated plans and also on the drone image submitted in the DDMS portal.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
