	1. Not carried out the Proposed Primary (On-lode) 520 Mts, Stope Development (On-
	Lode) 8th and 6th level 300 Mts, & Stope Production at S1-Block at 6th - 8th Level
	and Waste Rock Development at 6th - 8th Level 100 Mts.
	2. Total production proposed during the year 2023-24 including the incidental ore from
	primary and stope development and from stoping was 90885 Tonnes against which
	you achieved only 49115 T which is about 54% of the target production.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
