The following provision of Mineral Conservation & Development Rules, 2017 was found violated during inspection your above said mine on **28/10/2024** by Shri Prashant S. Hegde, Regional Mining Geologist of this office in presence of S/Shri Pramod Kumar Patra, VP (Mines), R. S. Raghuwanshi, Agent, P.S. Acharya, QP, Sanjay Kumar, Geologist & QP, A. Samal, Mines Manager and other mine officials.

Rule No.	Nature of violation observed
45(7)	On examination of submitted Annual Return of FY 2023-24, it is found to be in-complete /wrong as furnished below. (i) <u>Item No. 1 of Part-II A (Capital structure)</u> : Estimated market value of land has not matching at table. (ii) <u>Item No. 5 (iii) of Part-V</u> : Cumulative total nos of trees at end of the year to be mentioned. (iii) <u>Item No. 5 of Part-VI</u> : Grade selection i.r.o. 1,66,465 tonnes of quantity has not matching as compare to item No. 3(ii) of despatches.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. You are advised to **rectify the above violation immediately** and **intimate the position to this office within 45 (forty five) days** from the date of issue of this letter.
