विषय/Sub: Show Cause Notice for Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Ferozabad Limestone Mine (**ML No. 2558**) over an area of **765.22Ha** in Ferozabad, Kirani, Somnathahalli villages, Gulbarga Taluk, Kalaburagi (Gulbarga) District, Karnataka state. (**MINE CODE: 38KAR10018**)

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the under signed along with Dr. Mahantesh P, Junior Mining Geologist in presence of Sri. P. Venkateswara Rao, Mines Manager & Mining Engineer on **08/11/2024**.

Rule	Nature of violations observed
Rule 45(7)	As PART-III (Consumption of Materials): Item 2. Royalty, Rents, and Payments made to DMF and NMET (₹): (a) Royalty: The royalty paid for the year 2023-2024 is reported as Nil, and (b) dead rent payment of Rs. 16,00,000/- is reported in this section. However, in PART-VII: Cost of Production per tonne of ore-mineral produced, a royalty amount of Rs. 80 per tonne is included in the cost of production, but dead rent is not factored into the cost of production. There is contradiction in the reported figures between the two sections.

02. The Mining operations and dispatches may be suspended and any action under sub rule (7) of Rule 45 of MCDR, 2017 read with MCDR (Amendment) Rules, 2021.
03. The fine may be imposed for submitting incomplete/ wrong/ false information in Annual Return as per Schedule-II of MCDR (Amendment) Rules, 2021.
04. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017 read with MCDR (Amendment) Rule, 2021.
05. You are therefore, directed to show cause within a period of thirty **(30) days** from the date of issue of this notice, as to why action under sub rule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.
