Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Aminabad & Kairulabad Limestone Mine over an area of 95.345 Ha. in Aminabad & Kairulabad Villages, Ariyalur Taluk & District, Tamilnadu state.

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the undersigned in presence of Mr M R Raja Ranjith Singh, General Manager & Mr T C Gopi Rajesh Kumar, Sr. Manager on 04.09.2024:

Rule	Nature of violations observed
Rule 11(1)	Mining operations have not been carried out in accordance with the approved Review of Mining Plan document approved vide letter no. TN/ALR/LST/ROMP-1700.MDS dt: 15.12.2022 to the extent indicated below: (i) There was no proposal to remove any overburden during the year 2023-24 against which 41,086 cu.m. of overburden has been removed during the year. (ii) There was a proposal to excavate 14,70,635 tonnes of ROM during the year 2023-24 against which only 10,99,900 tonnes of ROM was excavated during the year. (iii) There was a proposal to generate 3,70,635 tonnes of Mineral Rejects during the year 2023-24 against which no mineral rejects were generated during the year.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62(1) of Mineral Conservation and Development (Amendment) Rules, 2024, with imprisonment for a term which may extend to two years or with fine which may extend to rupees five lakhs, or with both, and in the case of a continuing contravention, with additional fine which may extend to rupees fifty thousand for every day during which such contravention continues after conviction for the first such contravention.

03. The mining operation can be suspended under Rule 11(2) and/or prosecution be launched if the compliance of the rule is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
