विषय/Sub: Violation of provisions of Mineral Conservation & Development (Amendment) Rules, 2024, in respect of your Devarmalai Limestone Mine over 166.535 Ha having mine code 38TMN28002 in Devarmalai & Melapaguthi Villages, Kadavur Taluk, Karur District of Tamil Nadu.

महोदय/Sir,

The following provisions of the MCD(A)R, 2024 were found violated in your above mine during the inspection on 08/11/2024 by the undersigned in the presence of Mr. M. M. Ramesh, DGM (Mines), Mr M. Kalishkumar, Sr. Mgr. (Mines) & Mr. V. Sasikumar, Sr. Mgr. (Geology):

Rule No.	Nature of Violation
11(1)	Mining operations have not been carried out in accordance with the Modification to the Approved Review of Mining Plan approved vide Letter No. TN/KRR/MMP/LST-2089.MDS dated 19/01/2023 to the extent indicated below: (i) <i>There was a proposal to remove 4,12,600 m³ of overburden during the year 2023-24 against which only 2,87,606.31 m³ has been removed during the year.</i>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62(1) of Mineral Conservation and Development (Amendment) Rules, 2024, with imprisonment for a term which may extend to two years or with fine which may extend to rupees five lakhs, or with both, and in the case of a continuing contravention, with additional fine which may extend to rupees fifty thousand for every day during which such contravention continues after conviction for the first such contravention.

03. The mining operation can be suspended under Rule 11(2) and/or prosecution be launched if the compliance of the rule is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
