विषय/Sub: Violation of provisions of Mineral Conservation & Development (Amendment) Rules, 2024, in respect of your Sendurai Limestone Mine over 21.925 Ha having mine code 38TMN38047 in Sendurai Village & Taluk, Ariyalur District of Tamil Nadu.

महोदय/Sir,

The following provisions of the MCD(A)R, 2024 were found violated in your above mine during the inspection on 11/11/2024 by the undersigned in the presence of Mr. R. Ravikumar, DGM (Mines) & Mr. B. Vikram Pyus AGM (Mines):

11(1) Mining operations have not been carried out in accordance with the Review of Mining Plan approved vide Letter No. TN/ALR/LST/ROMP-1615.MDS dated 15/12/2020 to the extent		
	indicated below:	
	(i) There was a proposal to remove 21,200 m ³ of Topsoil during the year 2023-24 against which 23,600 m ³ of Topsoil has been removed during the year.	
	(ii) There was a proposal to remove 42,400 m ³ of Overburden during the year 2023-24 against which 52,410 m ³ of Overburden has been removed during the year.	
	(iii) There was a proposal to excavate 3,27,600 tonnes of ROM during the year 2023-24 against which only 2,43,338 tonnes of ROM was excavated during the year.	
	(iv) There was a proposal to backfill 4.5 Ha of mined out area during the year 2023-24 against which only 3.03 Ha was backfilled during the year.	

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62(1) of Mineral Conservation and Development (Amendment) Rules, 2024, with imprisonment for a term which may extend to two years or with fine which may extend to rupees five lakhs, or with both, and in the case of a continuing contravention, with additional fine which may extend to rupees fifty thousand for every day during which such contravention continues after conviction for the first such contravention.

03. The mining operation can be suspended under Rule 11(2) and/or prosecution be launched if the compliance of the rule is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
