The following provisions of the MCD(A)R, 2024 were found violated in your above mine during the inspection on 06/12/2024 by the undersigned in the presence of Mr. K. Saravanan, SDGM-Mines & Mr. S. Kesavan, DGM & Mines Manager:

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62(1) of Mineral Conservation and Development (Amendment) Rules, 2024, with imprisonment for a term which may extend to two years or with fine which may extend to rupees five lakhs, or with both, and in the case of a continuing contravention, with additional fine which may extend to rupees fifty thousand for every day during which such contravention continues after conviction for the first such contravention.
- 03. The mining operation can be suspended under Rule 11(2) and/or prosecution be launched if the compliance of the rule is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
