विषय/Sub: Violation of provisions of Mineral Conservation & Development (Amendment) Rules, 2024, in respect of your Anandavadi Limestone Mine over 110.685 Ha. having mine code 38TMN38002 in Anandavadi Village, Ariyalur Taluk & District, Tamilnadu state.

महोदय/Sir,

The following provisions of the MCD(A)R, 2024 were found violated in your above mine during the inspection on 10/12/2024 by the undersigned in the presence of Thiru. T. Santhakumar, Mines Manager:

11(1)	<p>Mining operations have not been carried out in accordance with the Review of Mining Plan approved vide Letter No. TN/ALR/LST/MMP-2110.MDS dated 13/02/2024 to the extent indicated below:</p> <ul style="list-style-type: none">i) There was a proposal to remove 73,240 m³ of topsoil during the year 2023-24 against which only 25,455 m³ of topsoil has been removed during the year.ii) There was a proposal to remove 1,40,742.67 m³ of overburden during the year 2023-24 against which 1,87,839 m³ of overburden has been removed during the year.iii) There was a proposal to excavate 11,51,412 tonnes of ROM during the year 2023-24 against which only 3,42,386.10 tonnes of ROM has been excavated during the year.iv) There was a proposal to excavate 3,45,423.60 tonnes of Mineral Rejects during the year 2023-24 against which only 2,58,842.20 tonnes of Mineral Rejects has been excavated during the year.v) There was a proposal to afforest 2 ha of area with 1,000 nos. of saplings during the year 2023-24 against which no afforestation has been carried out during the year.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62(1) of Mineral Conservation and Development (Amendment) Rules, 2024.

03. The mining operation can be suspended under Rule 11(2) and/or prosecution be launched if the compliance of the rule is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
