Show cause for Violation of provisions of Mineral Conservation & Development (Amendment) Rules, 2024, in respect of your Olaipadi Limestone Mine over 4.98 Ha having mine code 38TMN24006 in Olaipadi Village, Kunnam Taluk, Perambalur District of Tamil Nadu.

महोदय/Sir,

The following provisions of the Mineral Conservation & Development (Amendment) Rules, 2024 were found violated in your above mine during the inspection on 05/09/2024 by the undersigned in the presence of Mr. B. Vikram Pyus AGM (Mines):

Rule	Nature of violations observed
11(1)	Mining operations have not been carried out in accordance with the Final Mine Closure Plan approved vide Letter No. TN/PBR/LST/MP-1997.MDS(FMCP) dated 13/09/2023 to the extent indicated below: (i) There was a proposal to afforest 0.58 ha with 580 numbers of saplings during the year 2023-24 against which no afforestation has been carried out during the year. (ii) There was a proposal to erect fencing over 500 mt around the pit during the year 2023-24 against which no fencing has been erected during the year.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62(1) of Mineral Conservation and Development (Amendment) Rules, 2024, with imprisonment for a term which may extend to two years or with fine which may extend to rupees five lakhs, or with both, and in the case of a continuing contravention, with additional fine which may extend to rupees fifty thousand for every day during which such contravention continues after conviction for the first such contravention..

03. Your letter no. CCCPL/AW/OLD/2024-25/108 dated 15.10.2024 received by this office has been duly considered and found not satisfactory.

04. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.

05. Please note that no further notice will be given to you in this regard.
