विषय/Subject: Show cause for Violation of provisions of Mineral Conservation and Development (Amendment) Rules, 2024 in respect of your Anandavadi Limestone Mine over an area of 110.685 Ha. in Anandavadi Village, Ariyalur Taluk & District, Tamilnadu state.

महोदय/Sir,

The following provisions of the Mineral Conservation & Development (Amendment) Rules, 2024, were found violated in your above mine during the inspection carried out by the undersigned in presence of Thiru. T. Santhakumar, Mines Manager, on 10/12/2024:

Rule	Nature of violations observed
Rule 45(7)	Annual Return submitted for the year 2023-2024: 1) PART-I (General): a) Uploaded Document: PMCP Table in Excel was found not uploaded. b) Lease area utilisation as at the end of year: Area covered under current workings was found mis-reported. 2) PART-V (General Geology & Mining): a) Exploration: Exploration details have not been furnished. b) Reserves and Resources: Reserve & Resources positions at the beginning of the year do not tally with the same furnished in the last approved ROMP and the depletion therefrom, as applicable. c) Mineral Reject: Rejects generated during the year was found mis-reported. d) Overburden and Waste: Overburden generated during the year was found mis-reported. e) Trees planted: Number of trees planted during the year was found mis-reported.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62(1) of Mineral Conservation and Development (Amendment) Rules, 2024.

03. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why action under sub-rule (7) shall not be taken against you for the above offences.
