	The modifications to the Approved Mining plan was approved by IBM vide letter no. 279/1093/2017/BNG dated 16/11/1021 for the period 2021-22(1/10/2021 to 31/03/2022) to 2023-24 and Review and updation of mining plan was approved by IBM vide letter no. MCDR-MPC0FE/19/2023-BNG-IBM_RO_BNG dated 15/12/2023 for the period 2024-25 to 2028-29. The deviations observed in mining operation vis-à-vis approved document are given below.
	 i. It was observed during inspection that development of benches at Block-2 pit is not developed systematically with 8 m bench height and width as proposed between section S-13-13' to S-16-6', S-9-9 'as per proposal. ii. For the year 2023-24 a total plantation of 4075 nos. of plants at 1.63 ha is proposed against which plantation of only 1044 nos. of plants at 0.41 ha carried out as per the plantation figures

reported in Annual return 2023-24.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
