Pursuant to issuance of CBIC Notification No. 25/2024-Central Tax dated 09.10.2024, it may be noted that necessary compliance for the payment relating to Tax Deduction at Source under Section 51 of the CGST Act, 2017 on metal scrap, wherever applicable, is to be dealt directly by the Buyer with Seller. TDS at the rate of 2% under GST is applicable only when seller and buyer are both registered under GST as regular taxpayer. Since GST TDS is a compliance matter pertaining to the buyer & seller only, MSTC Limited as a Service Provider will not intervene in the matter. Accordingly, the payment is to be done strictly as per the Payment Schedule mentioned in the auction catalogue.

This supersedes General and Buyer specific terms and conditions wherever applicable.

**GST: Reverse Charge Mechanism**

1. Only those bidders who are registered with GST authority and a having valid GST registration no. should participate in this auction. The other bidders will not be allowed to participate in the auction and no complaint in this regard shall be entertained
2. As per notification no.36/2017 central tax (rate) dated 13.10.2017 and Notification no.37/2017 integrated tax (rate) dated 13.10.2017, principal/seller being Govt. Unit, GST and cess on goods will be deposited by buyer under reverse Charge mechanism.
3. It is the responsibility of the buyer to submit true copy of Gst certificate to the principal before taking delivery.
4. Seller has to ensure collection of true copy of GST Certificate from the registered buyers before giving delivery of goods to them.
5. The GST as applicable on the date of delivery shall be paid by the successful bidder and GST and Cess on such Goods shall be paid on Reverse Charge basis by the Registered Recipient.
6. The bidders shall be solely responsible for remitting the GST and any statutory liability in this regard and no liability what so ever shall be borne by the seller/ MSTC. The Goods & Service Tax (GST) is implemented with effect from 01st July 2017 in India. GST will be payable on all goods (whether scrap or otherwise).

- 3.0 All the materials are offered for sale on **AS IS WHERE IS** basis and where they are stacked. Material are sold on the assumption that bidders have inspected the same and know what they are buying, irrespective of whether they have first inspected the materials or not. No complain shall be entertained in this regard. The material offered for sale can be inspected prior to the due date of e-auction. For inspection of material & other related matters, bidders may contact PRINCIPAL officials.

**4.0) PAYMENT DETAILS:**

- 4.1) The successful bidders shall submit Earnest Money Deposit(EMD) by way of **challan through Bharatkosh** to Seller/IBM or as mentioned in the lot description/Sale intimation Letter fired to your mail within 7 days of confirmation of bid for Accepted Lots and within 7 days from the date of acceptance of the item/s by seller for Lots under STA. The EMD must be @10% of the net sale Value quoted (excluding taxes & and duties). Upon issue of the sale order the EMD shall automatically be converted into Security Deposit. The Security Deposit as specified in Sale Order shall be adjusted only at the time of final payment. It should be noted that failure to submit post bid EMD / SD within above stipulated time will result in automatic deactivation of buyer's login from MSTC System for a minimum period of six (06) months. Thus the bidders shall be debarred from participation in any auction being conducted by MSTC for a minimum period of six (6) months. Buyers login may however be activated only if full payment (Material Value + Applicable Taxes& Duties) is received within 22 days from the date of closing of e-auction including the date of auction.
- 4.2) The material value along with all the taxes and duties must be paid by the buyer in one installment within 14 days from the date of issue of Sale Acceptance letter by MSTC or 22 days from the date of closing of e-Auction, whichever is later and no installment payment will be allowed, unless otherwise stipulated in Lot / Item details.
- 4.3) **DEFAULT IN PAYMENT:** In case of default in payment of the balance Sale value within the prescribed time limits, the due payment may be made together with additional charges @1% per week or part thereof calculated on the full 100% Material Value for a maximum period of Two week . The post bid EMD/SD will be adjusted towards material value only on receipt of the balance Sale Value within the prescribed time. However, this shall not confer any right to the Bidder to

6.0) The Contract shall be treated as having been entered into as soon as the ink-signed Sale Order/Acceptance Letter is issued by MSTC. The period of contract shall be of sixty days from the date of last Delivery order by MSTC against full payment made by the party. The contract shall be deemed to be complete as soon as the Area is cleared of the entire material allotted or on completion of the period of contract as mentioned above, whichever is earlier.

7.0) All the materials are offered for sale on AS IS WHERE IS basis Ex- works owners. The rates must be offered ON UNIT BASIS FOR EACH LOT SEPARATELY NOT PART THEREOF i.e. in Rupees per unit only.

7.1) The quantities indicated against the lot are purely indicative. The quantity in actual may turn out to be more or less than the estimated quantity. In the event of quantity turning out to be more than the estimated quantity the buyer has to lift entire material and clear the site after making the required payment at the discretion of PRINCIPAL. In the event of actual quantity turning out to be less than the estimated quantity, the buyer shall not be entitled to claim any damages, loss of interest or compensation on this count. The material as offered has to be lifted by the buyer.

7.2) All kinds of scrap offered in respect of each allotted scrap would have to be taken by the buyer. No guarantee can be given regarding its quality and NO SEGREGATION WOULD BE ALLOWED.

8.0) The Rate must be quoted exclusive of all kinds of Duties and Taxes like GST, TCS etc. These will be charged extra as applicable. Any variation in GST tax or in any other kind of applicable tax and any fresh statutory levies will be borne by the buyers.

9.0) Bidder shall submit his/ their Income Tax clearance certificate (latest), partnership deed of organizations and when demanded by MSTC/ owners.

10.0) The Bidders/ customers' workmen shall have to abide by the rules & regulation including safety & security regulation of the relevant statutory acts. Entry inside the works / stores should only be against Gate pass for the men and equipment for which purchaser will have to apply well in advance before lifting commences.

11.0) The Buyer will employ his own labour and means; at his own cost and risk for removal/collection/shifting of scrap as per schedules and payment of wages/compensation to the labourers will be the sole responsibility of the buyer. The purchaser shall ensure that his workmen do not loiter around within the stores area of the factory areas. They shall not touch any material except those material shown to them. If any of his workmen is even found violating these restriction, the purchaser shall be responsible for making good the loss to the owners on which their decision shall be final and binding.

12.0) LATE PAYMENT PENALTY : For any delay in making payment within the time limit specified, the due payment may be made together with late penalty @ 1% per week or part thereof on the Sale Value for the period of delay within 14 days from the due date and thereafter on the sole discretion of PRINCIPAL only. PRINCIPAL or MSTC in consultation with PRINCIPAL reserves the right not to accept the payment with or without the late penalty after expiry of the above mentioned time limits or even within the aforesaid additional period of 14 days, at Principal/MSTC's (in consultation with principal) sole discretion and in such an event the sale of the lot will be automatically cancelled and the Earnest Money/Security Deposit (as the case may be) will automatically stand forfeited.

13.0) DELIVERY PERIOD: The successful bidders shall lift the specific material lying in the lot allotted to them by employing their own labour and transport at their own cost within 30 Days (Thirty Days) from the date of Delivery Order (including date of issue) by MSTC/Seller.

NON-DELIVERY:

a) Where goods are sold in lots and not by number of units, in the event of the lot or lots being found to be deficient in quantity, size, measurement, number and weight, as stated in the catalogue, purchaser shall have no claim against the Government or against the auctioneer for refund of the whole or any part of the purchaser money, or for loss of profit, interest, damages.

b) Where stores are sold by weight or number, and not on the basis of lots, and the purchaser fails to obtain delivery of the whole or a portion of the stores sold, he shall not be entitled to make any claim other than for proportionate refund of the sale of the undelivered quantity. He shall not be entitled to claim any damages, loss or profit interest or compensation or any other account.

For such items, only those Parties shall be eligible to bid who have Valid Registration Certificates from the State/Central Pollution Control Board (PCB)/MoEF on the Starting Date of e-Auction. If the responsibility of the buyer to submit Renewal Certificate in time for updation in MSTC Records, failing which they may not be allowed to participate in such auction.
