Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Pimperkunta Manganese mine (32.63 ha) in Pippalakoti village, Bheempur Mandal, Adilabad district, Telangana.

Sir,

On verification of the office records on 01.11.2024, it is observed that the following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine.

Rule	Nature of Violation
35(2)	<p><i>Every holder of a mining lease shall monitor his mining and allied activities as per the template of star rating in the format specified in this behalf by the Indian Bureau of Mines from time to time, and shall submit online its self-assessment report before the 1st day of July every year for the previous financial year, to the Regional Controller or the authorised officer of the Indian Bureau of Mines:</i></p> <p>However, it was noticed that till date you have not filed the Star Rating template as per statute.</p>

02. You are therefore, directed to show-cause within a period of 45 days giving reason for non-submission of star rating template as per statute. Or else, your mine can be issued order of suspension of mining operations under Rule 35(4A) of MCDR, 2017.

03. It is again brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017

04. In case of non-filing of template as stated in sub-rule (2), the holder of mining lease shall be liable to pay an amount of ten thousand rupees per day for such delay to the authorised officer of the Indian Bureau of Mines.

05. Please note that no further notice will be given to you in this regard.
