विषय/subject: Violation of provisions of MCDR, 2017, in respect of your Bangur Chromite Mine (11ORI08001) over an area of 139.94 Ha. in Village-Bangur, Dhanurjaypur and Kushatikiri Taluka- Anandpur, Keonjhar district of Odisha State-.

महोदय/Sir,

The following provisions of MCDR 2017 were found violated in your above mine during the inspection carried out on 26/11/2024 by the undersigned in presence of the mine officials S/Shri Susanta Kumar Naik, Mines Manager, Debasis Nayak, Geologist alongwith other mine officials.

11(1)	The Modification of Mining Plan with PMCP was approved vide letter no. MPM/A/07-ORI/BHU/2019-20 dated 06.11.2019 for a period of 2020-21 to 2024-25. The deviation observed in mining operation vis-a-vis approved document are given below: 1. During FY 2023-24 it was proposed to produce 60000 tons of ROM against which only 22615 tons of ROM was achieved.
31(4)	During inspection it was observed that the upto date plans and sections were not found to be maintained.
32(1)	During the inspection it was observed that the features shown in Surface Plan, Surface Geological Plan and Geological Sections did not match with each other and also were not indexed accordingly.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.

03. You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.
