Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 15/07/2024 in the presence of your representative Shri Sanket Patil (Mining Engineer) and other mines officials. The document of above mentioned mine was approved vide letter No. MP/Balaghat/Manganese/MPLN/MOD-05/2020-21 dated 24.09.2020 incorporating proposal of working from 2020-21 to 2023-24. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.
