C I R C U L A R

One post of Chief Chemist in the Level-13 (Rs.123100 - 215900) is vacant in Indian Bureau of Mines under the Ministry of Mines and is to be filled up by Deputation including short term contract.

02. The Chief Chemist is responsible to work as an In-charge of Chemical Analysis Section of Nagpur Laboratory and planning, supervision, co-ordination and monitoring the work of Chemical Laboratory of Regional Ore Dressing Laboratory, Bangalore & Ajmer involving Classical wet methods of analysis of ores, minerals & ore dressing products generated during the test work. Various instrumental methods of analysis of ores and mineral samples and Environmental analysis of soil mine's effluents and ambient air samples, as per the guideline of Central Pollution Control Board, Ministry of Environment and Forest. Stores requirement, maintenance of equipment, instrument and other related jobs pertaining to chemical and environmental laboratory.

03. As per the Recruitment Rules for the post of Chief Chemist, the candidate to be considered for appointment by deputation including short-term contract should be the officers under the Central Government or State Governments or Union Territories or Public Sector Undertakings or recognized research institutions or Universities or semi Government or statutory or Autonomous Organisations : -

- (c) (i) Holding analogous posts on regular basis in parent cadre or department;
or
(ii) With five years service in the grade rendered after appointment thereto on a regular basis in Level-12 in the pay matrix (Rs.78800 - 209200) or equivalent in the parent cadre or Department; and
- (d) Possessing the following educational qualification and experience.

Essential:-

- i) Master's degree in Chemistry from a recognized University or Institution.
- ii) Twelve years' experience in chemical analysis of ores and minerals in a laboratory recognized as a Research Laboratory by Council of Scientific and Industrial Research or Department of Science and Technology or any other such government organization carrying out chemical analysis of ores and minerals.

Desirable: Doctorate degree in chemistry from a recognized University.

Note-1:- The Departmental officers in the feeder grade who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note-2:- Period of deputation in another Ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed five years.


Note-3:- The maximum age limit for appointment by deputation shall be not exceeding fifty – six years as on the closing date of receipt of applications.

04. The deputation period will be initially for 03 years and will be considered for further extension on the basis of requirement of this department and NOC from the parent department. However, the officer may also consider for pre-mature reversion to the parent cadre by serving 03 months advance notice to the parent department as well as to the officer in terms of provisions contained under DOPT OM No.6/8/2009-Estt.(Pay II) dated 17.06.2010.

05. Application containing the bio-data (in triplicate) of the officer who fulfills the above as on the closing date may be sent through proper channel addressed to **The Controller of Mines (P&C), 2nd Floor, Indian Bureau of Mines, Indira Bhavan, Civil Lines, Nagpur - 440 001** in the enclosed bio-data proforma (Annexure - I) within 60 days from the date of publication of advertisement in the Employment News alongwith the up-to-date Confidential Reports/Dossiers for the preceding 5 years, Integrity Certificate, Vigilance Clearance and No penalty certificate for preceding 10 years of the officer concerned. Applications received after the closing date will not be entertained. Also, advance copies of applications or not accompanied with all the above certificates/enclosures are liable to be rejected.

06. The Candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
