Sub.: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect to **Birhuli Limestone Mine**, (Mine Code 38MPR35309), **Area** 56.27 hectares, situated in village Birhuli, Satna District of Madhya Pradesh State.

Madam,

The following provision of Mineral Conservation and Development Rules 2017 were found violated in your above mentioned mine during the inspection by the undersigned on 27/08/2024 in presence of Shri Kumar Rajan (Mines Manager), Shri. Gaurav Tripathi (Geologist).

Rule No	Nature of violation observed in detail
<p>Rule 11(1).</p>	<p><i>Mining operations under mining lease.-(1) No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5</i></p> <p><i>During inspection it has been observed that the following provisions of the rule have been violated: -</i></p> <p>For the reporting year 2023-24 the development is proposed in between E 489303 to E 489490 and N 2723160 to N 2723466, E 489092 to E 489482 and N 2722896 to N 2723192, E 489661 to E 489973 and N 2723071 to N 2723225 whereas the deviation in proposed location is observed.</p>

Rule 45(7)	<p><i>If it is found that the holder of a mining lease or the person or company engaged in trading or storage or end-use or export of minerals, as the case may be, has submitted incomplete or wrong or false information in monthly or annual returns or fails to submit a return within the date specified; then, –</i></p> <p><i>(a) in the case of mining of minerals by the holder of a mining lease, the Regional Controller of Mines or the authorized officer of the State Government may -Order suspension of all mining operations and dispatches in the mine and to revoke the order of suspension only after ensuring proper compliance; Take action to initiate prosecution under these rules;</i></p> <p>Refer PART-I Upload Document</p> <p>The attached Kml/Kmz file should contain the lease boundary, polygon representing the reporting year development and cumulative land use details whereas only lease boundary details are depicted.</p>

2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017 and that non-compliance of rule 12 (4) shall be punishable with fine of Rs 5,00,000/-.
3. Non-compliance of rule 11(1) of MCDR, 2017 may lead to suspension of mining operation under the provision of rule 11(2) of MCDR-2017.
4. You are advised to rectify the above violations immediately and intimate the position to this office within a period of 45 days from the date of issue of this letter.
