Subject: - Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Badiya Limestone Mine over an extent of 4.028 hect, Mine Code: - 38MPR403003 in Dhar District of M.P.

Sir, Following provisions of MCDR 2017 were found violated in your above mine during the inspection by the Undersigned on 26/06/2024 in the presence Shri Vijay Chakunde (Mining Engineer), Shri Ajit Kumar (Mine Geologist) & Mine officials:

Rule No	Nature of violation observed in detail
11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government.
	The Initial Mining Plan of above mentioned mine was approved vide letter No. MP/Dhar/Limestone/MPLN/G-12/19-20 dated 20/03/2020 incorporating proposal of working from 2020-21 to 2024-25 and following deviations have been observed:
	(a) Only 52000 tonnes of Limestone is produced against the proposal of 70454 tonnes for the year 2023-24.
	(b) Refer Page 53-54 of Chapter No.4.0, during the year 2023-24 it was proposed to maintain waste dump in the northeastern part of the lease between the coordinates N2473350 - N2473445 & E508920- E508980. But during the year, the said waste dump was not maintained.
	(c) During the inspection, excavations were found extended within 7.5m statutory barrier zone and beyond mining lease area between the ML boundary pillars nos. BP-01 to BP-02 & BP-02 to BP-03.
	Hence the development & excavation were found lagging behind the approved proposals.
33	The holder of a mining lease shall, on or before the 30th day of June every year submit to the authorized Officer, as the case may be, and the State Government, a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. Copies of plans and sections under rule 32 of MCDR-2017 have not been submitted.
45(7)	The holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorised official of the Indian Bureau of Mines in the following manner. An annual return which shall be submitted before the 1st day of July each year for the
	preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed, in the respective Form. The following discrepancies found in your submitted annual return for the year 2023-24: • The .kml file attached is incomplete and various surface features including boundary pillars are not marked.
	 PART-5 S.No.05 (Trees planted- survival rate). The details wrt to Total no.of trees at the end of the year is incorrectly furnished.

- 3. You are advised to rectify the violations of abovementioned rules immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
