Subject: - Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Lalpur Limestone Mine over an area of 17.471 hect. having Mine Code 38MPR35295 situated in Satna district of M.P. State.

Sir, Following provisions of MCDR 2017 were found violated in your above mine based on the examination of submitted Satellite imagery and inspection by the Undersigned on 18/07/2024 in the presence of Shri J.L. Saraf (Mines Manager), Shri Vikas Singh (Mine Geologist) & Mine officials:

Rule No	Nature of violation observed in detail
11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government.
	The Initial Mining Plan of above mentioned mine was approved vide letter No. E 6701 MCDR-MPC0LST/16/2023-JBP-IBM_RO_JBP dated 28/07/2023 incorporating proposal of working from 2023-24 to 2027-28 and following deviations have been observed:
	(a) Refer 4A.2.2.2: Yearwise Opencast Development – I, , during the year 2023-24 it was proposed to carryout development of Quarry 1 in the north between the coordinates N2724350 - N272430 & E484580 - E484710 and in Quarry 2 in the south between the coordinates N 2723915– N 2724000 & E 484115- E 484185. But during the year, the development of Quarry 2 was not done.
	(b) Refer Page 53-54 of Chapter No.4.0, during the year 2023-24 it was proposed to maintain waste dump in the northeastern part of the lease between the coordinates N 2724100- N 2724225 & E 484130 - E 484220. But during the year, the said waste dump was not maintained.
	Hence the development & excavation were found lagging behind the approved proposals.
33	The holder of a mining lease shall, on or before the 30th day of June every year submit to the authorized Officer, as the case may be, and the State Government, a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. Copies of plans and sections under rule 32 of MCDR-2017 have not been submitted.
45(7)	The holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorised official of the Indian Bureau of Mines in the following manner.
	An annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed, in the respective Form. The following discrepancies found in your submitted annual return for the year 2023-24:
	 The .kml file and PMCP report are not attached. PART-1 S.No.07: The details wrt to Manager not provided.

- 1. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 2. The mining operations can be suspended under the rule 11(2) & 45(7) of MCDR-2017, if compliance of rule 11(1) & 45(7) of MCDR-2017 read with MCDR-2021 (Amendment) is not found satisfactory.
- 3. You are advised to rectify the violations of abovementioned rules immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
