**Sub:** Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Lanjiberna Limestone and Dolomite Mines (38ORI13014) over an area of 873.057 Ha situated in SUNDARGARH district of Odisha State-Reg

Sir,

The following provisions of MCDR 2017 were found violated in your above mine during inspection carried out on 17th October 2024 by the undersigned in presence of the mine officials Shri P Vikram, Mines Manager(I/C) and Dr U Sahoo, Geologist.

Rule	Nature of Violation observed
11(1)	Mining operations are not being undertaken in accordance with the Mining Plan/ Modification of Mining Plan. The Modification of Mining Plan was approved vide letter no. MCDR-MiFLOLST/5/2022-BBS-IBMROBBS Dated 17.11.2023 and following deviation was observed during inspection 1. In 2023-24 the exploration proposed for 55 nos of core drilling of 5500 meter but 11 nos bore hole of 1351.00 meter drilling done. 2. The production in 2023-24 proposed for 9.5 million Tons of ROM but achievement is only 5.9 million tons

**02.** In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

**03.** The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

**04.** You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.
