विषय/Subject : Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Kalburgi Cement Kharchikhed Limestone Mine (ML No. 2676) (Mine Code-38KAR10020) over an area of 465.39 ha in Kalaburagi district of Karnataka State.

महोदय/Sir,

The following provisions of Mineral Conservation and Development Rule, 2017 (MCDR, 2017) were found violated in respect of the above said mine during virtual inspection on 10.02.2025 by Shri A K Pany, AME based on Digital Aerial Images submitted under Rule 34A of MCDR, 2017 and other office records.

45(7)	In the Annual Return submitted for the year 2023-24, following
	discrepancies were observed:-
	 (i) In Sl. No. 1(i) of PART-V, the information on exploration i.e. no. of holes at the beginning of the year and cumulative is furnished as '0' (zero). The same is not tally with information as per latest approved mining plan. (ii) In Sl. No. 2 of PART-V, the information on reserve/resource at the beginning of the year and balance as on 31.03.2024 is not tally with reserve/resource figure of last approved mining plan after depleting production achieved. (iii) In PART-VII, the production proposal for the financial year 2023-24 is furnished as '0' (zero). The same is not correct.

- 02. The mining operations and dispatches may be suspended and any action under subrule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
- 03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 04. You are therefore directed to show cause within a period of **thirty (30) days** from the date of issue of this notice, as to why action under sub-rule (7) of Rule 45 of and Rule 62 of MCDR (Amendment), 2021 shall not be taken against you.
- 05. You are advised to rectify the above violations immediately and intimate the position to this office **within 30 (thirty) days** from the date of issue of this notice.
