Subject: Violation of provisions of MCDR, 2017, in respect of your Nuagaon Iron & Mn. Ore Mine (40ORI13050) over an area of 29.257 Ha. in Nuagaon village, Koira Tahsil of Sundergarh District of Odisha State- reg.

महोदय,

The following provision of MCDR 2017 were found violated in your above mine during the inspection carried out on 10th January 2025 by the undersigned in presence of the mine officials Sri T. C. Sei (Mines Agent), Sri A. N. Prasad (Mines Manager), Sri Soukeen Mohanta (Geologist).

Rule Number & Nature of violations observed

Rule 11(1): Mining operations in the mining lease are not being carried out in accordance with the proposal given in the approved mining plan, approved vide dated 14.11.2018 to the extent given below;

- i) It has been observed during the mine inspection that, a total of 105705 tons ROM of iron ore and 13350 tons of Manganese ore proposed for production during FY 2023-24 and as per annual records, about 33360 tons ROM of iron ore and 480 tons of Manganese ore were produced during FY 2023-24, which is about 31.55 % in iron ore and 3.60% in Manganese ore only of the annual proposal.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty-five) days from the date of issue of this letter.
