**Sub:** Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Khatkurbahal and Falsakani Limestone Mine (38ORI373001) over an area of 156.43 Ha situated in Sundergarh district of Odisha State-Reg.

Sir,

The following provisions of MCDR 2017 were found violated in your above mine during inspection carried out on 11th January 2025 by the undersigned in presence of the mine officials.

<b>Nature of Violation observed</b>
<p><b>11(1):</b> Mining operations are not being undertaken in accordance with the Mining Plan/ Modification of Mining Plan.</p> <p>The following deviation was observed during inspection,</p> <ol style="list-style-type: none"> <li>1. The proposed production for FY 2023-24 is 901800 tonne of ROM but achievement is only 197798 tonne which is 21%.</li> <li>2. Height and width of benches are not maintained as per proposal in the two quarries i.e Quarry 2 and Quarry 3.</li> <li>3. In FY 2023-24, the development has not achieved as per the Proposal in Quarry 2 and Quarry 3 and Development work has not started yet in Quarry 1.</li> </ol>

**02.** In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

**03.** The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

**04.** You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.
