Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Khatkurbahal and Falsakani Limestone Mine (38ORI373001) over an area of 156.43 Ha situated in Sundergarh district of Odisha State-Reg.

Sir,

The following provisions of MCDR 2017 were found violated in your above mine during inspection carried out on 11th January 2025 by the undersigned in presence of the mine officials.

	Nature of Violation observed
11(1):	Mining operations are not being undertaken in accordance with the Mining Plan/
	Modification of Mining Plan.
	The following deviation was observed during inspection,
	1. The proposed production for FY 2023-24 is 901800 tonne of ROM but achievement
	is only 197798 tonne which is 21%.
	2. Height and width of benches are not maintained as per proposal in the two quarries
	i.e Quarry 2 and Quarry 3.
	3. In FY 2023-24, the development has not achieved as per the Proposal in Quarry 2
	and Quarry 3 and Development work has not started yet in Quarry 1.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.
