Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Asurabandha Chromite Mine (11ORI05004) over an area of 91.827 Ha situated in Dhenkanal district of Odisha State-Reg

Sir,

The following provisions of MCDR 2017 were found violated in your above mine during inspection carried out on 30th November 2024 by the undersigned in presence of the mine officials.

Rule	Nature of Violation observed
11(1)	Mining operations are not being undertaken in accordance with the Mining Plan/ Modification of Mining Plan. The Modification of Mining Plan was approved vide letter no. RMP/A/54-ORI/BHU/2020-21 dated 30.03.2021 and following deviation was observed during inspection 1. The proposed production for 2023-24 is 24038 tonne of ROM but achievement is only 7 tonne.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.
