The following provisions of MCDR 2017 were found violated in your above mine during inspection carried out on 6th November 2024 by the undersigned in presence of the mine officials.

**02.** In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

**03.** The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

**04.** You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.
