

Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Arjuni Manganese Mine over an extent of 11.57 hectares in Sihora Tehsil, in Jabalpur District of Madhya Pradesh State.

Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 06/01/2025 in the presence of your representative Shri Vinay Surana, Shri Neeraj Shrivastav (Mining Engineer), Shri Rajeev Goel (Geologist) and Other Mine official. The document of above mentioned mine was approved vide letter No. MP/Balaghat/MN/MPLN/MOD-17/2022-23 dated 08.07.2022 incorporating proposal of working from 2022-23 to 2026-27. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

- 03. Further, non-compliance of the rule 11(1) of MCDR, 2017 may lead to the suspension of mining operations under the provisions of rules 11(2) of Mineral Conservation and Development Rules, 2017.
- 04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
