Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 16/07/2024 in the presence of your representative Shri Ajay Khandelwal, Shri Sushil Kumar (Mining Engineer) and Shri Brijkishor Rahangdale. The document of above mentioned mine was approved vide letter No. E 9019 MCDR-MPC0Mn/18/2023-JBP-IBM_RO_JBP dated 19.01.2024 incorporating proposal of working from 2023-24 to 2027-28. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.
