Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Jam Manganese Mine over an extent of 8.09 hectares in Balaghat Tehsil, in Balaghat District of Madhya Pradesh State.

Madam,

Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 06/01/2025 in the presence of your representative Shri Rajesh Rawal, Shri Yogesh Thakre (Mining Engineer), Shri Shiv Narayan Banskar (Geologist) and Other Mine official. The document of above mentioned mine was approved vide letter No. E 2246 MCDR-MPC0Mn/3/2022-JBP-IBM_RO_JBP dated 15.05.2023 incorporating proposal of working from 2023-24 to 2025-26. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

	During the year 2023-24, it was proposed to drill 08 numbers of boreholes and their locations were marked in the approved Surface Geological plan.	In 2023-24, 08 (919 mtr) numbers of boreholes were proposed but these boreholes were not drilled as per their proposed location shown in the approved Surface Geological plan.
	During the year 2023-24, Dump working was proposed from Dump 2.	During inspection it was found that dump working was done from Dump-1 instead of Dump-2. Thus the violation of provisions of the approved mining plan.
	Para - 4A.3.3 of approved Mining Plan: Around 5% recovery from Dump workings has been considered.	Around 83% recovery was found from Dump working. This is not acceptable recovery from Dump working.

45(7)	If it is found that the holder of a mining lease or the person or company engaged in trading or storage or end-use or export of minerals, as the case may be, has submitted incomplete or wrong or false information in daily or monthly or annual returns or fails to submit a return within the date specified. 02. Further, it is brought to your notice that the above violations constitute an offense punishable under rule 62 of Mineral Conservation and Development Rules, 2017.
03. Further, non-compliance of the rule 11(1) of MCDR, 2017 may lead to the suspension of mining operations under the provisions of rules 11(2) of Mineral Conservation and Development Rules, 2017.
05. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
