Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Koldiya no. -02, Bauxite Mine over an extent of 45.892 hectares in Ramnagar Tehsil, in Satna District of Madhya Pradesh State.

Sir,

Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 11/09/2024 in the presence of your representative Shri Ramchandra Agrawal and Other Mine official. The document of above mentioned mine was approved vide letter No. MP/Satna/Limestone/MPLN/MOD-13/2019-20 dated 25.09.2019 incorporating proposal of working from 2019-20 to 2023-24. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

02. Further, it is brought to your notice that the above violations constitute an offense punishable under rule 62 of Mineral Conservation and Development Rules, 2017.

03. Further, non-compliance of the rule 11(1) of MCDR, 2017 may lead to the suspension of mining operations under the provisions of rules 11(2) of Mineral Conservation and Development Rules, 2017.

04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
