Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Ronsara Bauxite Mine over an extent of 5.22 hectares in Majholi Tehsil, in Jabalpur District of Madhya Pradesh State

Sir,

Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 12/08/2024 in the presence of your representative Shri Arun Chopra, Shri Akash Nagwanshi (Mining Engineer) and Other Mine official. The document of above mentioned mine was approved vide letter No. E 4765 MCDR-MPC0BXT/1/2023-JBP-IBM_RO_JBP dated 10.04.2023 incorporating proposal of working only 2023-24. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
