Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 (Amended up to 3/11/2021) in respect of your Khatamba Rock Phosphate Composite Licence Block (42.20 Ha) in Meghnagar Tehsil, District Jhabua of Madhya Pradesh State regarding.

Sir,

Following provision of Mineral Conservation and Development Rules 2017 (amended 3/11/2021) were found violated during the inspection of the above cited block by the undersigned on 20.02.2025 in the presence of Shri Raj Kumar Yadav, Senior Manager (Geology) and Shri Atik Arab, Mining Engineer

Rule No	Nature of violation observed in detail
Rule 6	 Reconnaissance or prospecting operations to be carried out in accordance with scheme of reconnaissance or prospecting Following discrepancies are observed in the Scheme of Prospecting submitted to this office vide letter dated 07/06/2023 1. It was proposed in Scheme of Prospecting (SOP) to carryout Surface Geological mapping as per para 4(i)(b), whereas the same has not been carried out.
	 The core drilling grid interval for the irregular habit mineral deposit is 100x100m for G1 level of exploration, whereas the proposed SOP are inconsistent with MEMC rules, 2015
Rule 12(5)	The sampling of drill cores or chips, pit samples and trench samples shall be done for the entire mineralised portion at regular intervals, preferably meter wise or less, and chemical analysis for the major radical shall be done for all the samples. 1. No chemical analysis of drilled bore hole done so for
