Sir,

The undersigned inspected your mine on 26.10.2024 in presence of Shri Vijay Keshav Chakunde, Senior GM (Mines) and other mines officials. Mining Plan was approved vide letter no. MP/Dhar/Limestone/MPLN/G-01/2020-21 dated 24/09/2020 for the plan period of five years from the date of agreement Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.
