

Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your RODADA Limestone Mine (44.465 Hectares, Mine Code: 38MPR403004) in Rodada Village, Gandhwani Tehsil, in Dhar District (MP)..reg.

Sir,

The undersigned inspected your mine on 26.10.2024 in presence of Shri Vijay Keshav Chakunde, Senior GM (Mines) and other mines officials. The Mining Plan approved vide letter No.-MP/Dhar/Lst./MPLN/G-14/2019-20 dated 20.03.2020 for the plan period of five years from the date of agreement. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.
