महोदय / Sir,

On the basis of basis of office records following provisions of MCDR 2017 were found violated in your above mentioned mine;

Rule 45(5) the holder of a mineral concession shall submit online return in respect of each mine to the Regional Controller of Mines and the authorized officer of the Indian Bureau of Mines.

Rule 45(5) (b) a monthly return shall be submitted before the tenth day of every month in respect of the preceding month in electronic form along with a signed print copy of the same.

Rule 45(5) (c) an annual return shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same.

As per office records you have not submitted returns online mode. Therefore, you are requested and advised to submit returns in the online portal.

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
