Subject:- Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Luhani Rock Phosphate Mine, over an area of 13.20 hectare, situated in village-Luhani, Tehsil : Baxwaha , District Chhatarpur of Madhya Pradesh State.

Sir,

Undersigned has inspected your mine in the presence of your representative Shri Rajneesh Mishra (Agent), Shri Praveen Rawat (Geologist) on 18/01/2025. Following provisions of MCDR 2017 were found violated in your mines at the time of inspection.

11(1)of MCDR 2017	<p>1. Mining operations under mining lease.-(1) No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2)</p> <p>The document of above mentioned mine was approved vide letter No. E 12695 MCDR-MPCOP/1/2025-JBP-IBM_RO_JBP dated 10/03/2025 incorporating proposal of working from 2025-26 to 2029-30</p> <p>During inspection it has been observed that the following provisions of the rule have been violated: -</p> <p>1. Dumping was done outside the lease boundary.</p>

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
- You are advised to rectify the violations of above mentioned rules immediately and intimate the position to this office within 45 (days) days from the date of issue of this letter.
